Screenwriting Project Offered In Two Formats

ue to its popularity and COVID-19 safety protocols, The Laboratory Theater of Florida's 24-Hour Playwriting Project has been modified again this year to The 24-Hour Screenwriting Project. This year, the project is also a virtual fundraiser for the theater, allowing patrons to vote for their favorite short film, cast or writer via the ticketing portal with a donation of any amount.

This event is a variation on the perennial favorite. The premise is: gather four playwrights who will meet virtually at 8 p.m. on Friday, October 8. They will receive a theme, instructions and the three lines that the playwrights must include in each five- to seven-minute screenplay. After a night of writing, they meet their directors via video chat over breakfast for final edits. At lunch, the actors meet their cinematographer/director, who will be filming their work. The short movie is filmed and edited. A few hours later, the video is ready for viewing.

Historic Downtown Fort Myers, Then And Now:

To The Sweetest Man In Town

'n August 1953, Mrs. George H. McCann of Glenside, Pennsylvania addressed a picture postcard of the Royal Palm Court to "the Sweetest Man in Town" in Key West, Florida. She put a two-

One can only wonder what the post office did with it, for she did not include a street address. Maybe,

cent stamp on it and mailed it from

in 1953, everyone knew exactly who that resident of Key West was.

Fort Myers.

Like most postcard messages, it was perfunctory: "Keeping my promise to write. My sisters and I enjoyed our tour with you, blarney and all.

Royal Palm Court was then a relatively new motor court, or tourist court, as they were called then. It had

opened in February 1948, just in time for high season.

Pictured here circa 1950, it was located on Cleveland Avenue on the southeast corner at Franklin Street.

It promoted itself as "ultra modern" in a time when air conditioning, swimming pool, telephone and television were not yet standard amenities.

From opening day, the motor court also advertised innerspring mattresses, down pillows, built-in Venetian blinds, palmfrond-print drapes, fans, soft water, private parking spaces, room service and fireproof construction.

The court's "sparkling white linens" were laundered by Prather's, the well-known local business.

The court advertised recommendations by AAA; Quality Courts, Inc.; and the National Automobile Association.

But evidently, it was tile baths and steam heat that the business thought would impress travelers most, for those are featured on the sign out front.

The court's location was a plus. A less than three-minute travel time to the business district made it convenient for shopping and church-going, ads read.

The golf course and fishing piers were nearby, and it was only a few minutes' drive to beaches and "picturesque islands."

By the mid-1950s in Fort Myers, the growing number of hotels and motels upped competition. Within two or three blocks of the Royal Palm alone were the Driftwood Motor Lodge and Edgepark Court.

And, a Howard Johnson's motel and restaurant had opened on the opposite corner at Franklin.

The Royal Palm had a decades-long run. Today, the site is the parking lot for a medical center.

Visit Cleveland and Franklin and imagine spending a few days at a classic motor court - with tiled bath and palmfrond-print drapes, no less!

Then visit the following research centers to find out just how many motels and hotels were needed to accommodate all those tourists in the post-World War II era.

Coastal Cleanup Nets Over 3,000 Pounds Of Trash

eep Lee County Beautiful, Inc. (KLCB) is the local organizer of the International Coastal Cleanup (ICC). Since the first ICC, more than 16 million volunteers have removed over 340 million pounds of trash from more than 500,000 miles of shoreline.

Keep Lee County Beautiful had over 1,200 volunteers at 43 sites across the county on September 18. The volunteers participated in shoreline cleanups, waterway cleanups in kayaks, and a dive cleanup on Captiva. In addition to removing over 3,000 pounds of litter and debris from Lee County, volunteers contributed to the world's largest database on marine debris by collecting data which will be sent to the Ocean Conservancy. This data is used by scientists, environmentalists, governments and others to better understand and characterize the global plastic pollution problem.

The data shows that 80 percent of global litter is plastics and is dominated by food and beverage items. Every year, 78 million tons of plastics enters the oceans, entangling wildlife, polluting beaches and costing coastal municipalities hundreds of millions of taxpayer dollars. All the top-10 most-collected items were made of plastic, including cigarette butts (which contain plastic filters), plastic bottles, food wrappers, plastic bottle caps, plastic

utensils, grocery bags and straws. These plastics never fully biodegrade. They break up into smaller pieces, called microplastics, which are the growing concern of the global plastic pollution.

The last 35 years of the International Coastal Cleanup have proved that everyone has a role to play in stopping plastic pollution. Individuals can do their part by joining cleanups, cutting out single-use plastic items by looking at their shopping habits and refusing, and reducing plastics.

Artists Sought For Outdoor Work At New Fire Station

The Fort Myers

a representational,
three-dimensional
outdoor artwork
to be installed
at a new fire
station serving
the City of Fort

Myers. The sculpture is to be installed at Station 17, a Missile Level E Essential Facility providing fire and EMS services to business locations and residential developments along Six Mile Cypress Parkway that are located south of Colonial Boulevard and north of Daniels Parkway, as well as the southbound lanes of I-75. Located in Ward 6 (represented by Councilperson Darla Bonk), the station is expected to be completed in late spring or early summer of 2022.

Although representational, the sculpture or sculptural installation may possess modernist stylings or flair. The Fort Myers Fire Department and Station 17 would like the piece's design to accommodate small groups who may

gather for memorial events such as 9/11 commemorations and observances for fallen firefighters and police.

The facility is being designed by BSSW Architects, Inc. The site plan for Station 17 offers a number of possibilities for the artwork's location, including the area outside the multiuse and educational room, at or alongside the flagpole, and adjoining the parking lot that faces Six Mile Cypress Parkway. (The architectural site plan is appended to the call to artists so that interested artists can visualize possible locations for the artwork.)

Funding for the project is provided by the City of Fort Myers Public Art Fund. The total budget for the artwork is \$50,000, which covers materials, photo courtesy www.artswfl.com

engineering, fabrication, permitting, transportation, travel, installation, insurance, documentation, contingencies and the artist's/artist team's fee. While it will be the artist's responsibility to provide engineering for footers, anchor bolts and concrete or other pad, the Station 17 building contractor will form and pour the pad and footers for the sculpture and provide electrical service for any backlighting or up-lighting that the artist wishes to include in the sculpture's design. LED is preferred.

Artists who reside in the United States and U.S. territories are eligible to apply. All applicants will be considered regardless of race, gender, gender variance, sexual orientation, national origin, age, religion, marital status, political opinion or affiliation, or mental or physical ability. Minority artists living in the United States and U.S. territories are encouraged to apply.

The deadline for submissions is midnight Tuesday, November 30. Submissions must be made on Café. To find the call to artists/RFQ, visit https://artist.callforentry.org/festivals_unique_info.php?ID=9484.

On Tuesday, December 21, a selection committee consisting of members of the public art committee, a member-at-large of the surrounding community, and designees of the Fort Myers Fire Department and BSSW Architects will choose three finalists from the submissions received. The winning artist will be selected following a virtual presentation of the finalists' designs on Tuesday, February 15. Both meetings are open to the public.

Fabrication and installation is slated for June 1 through August 31, 2022.

Pre-Registration Open For 2022 Kindergarten Year

The School District of Lee County recently opened pre-registration for students who will start kindergarten in August 2022. Pre-registration is available until November 30. Signing up early allows parents to avoid the lengthy wait times often experienced during the traditional student enrollment period.

"Last year, we had 2,500 new kindergarten students who could have secured a seat in the same kindergarten through fifth grade elementary school as their older siblings by registering early, and only 500 did so," said Soretta Ralph, executive director of student enrollment. "Some of those remaining 2,000 kindergartners are attending different schools than their brother or sister right now because they waited until open enrollment or later to register. Every family can avoid that happening to them by taking advantage of preregistration and enrolling their incoming kindergartner now."

Students entering kindergarten in August 2022 must be age 5 on or before September 1, 2022.

The documents required to preregister include:

Physical exam (dated within the last year)

Florida certificate of immunization Proof of address Original birth certificate Social security card (if available) Custody documents (if applicable) Parent photo ID Registration form

Parents may pre-register their children online by providing all documents to studentenrollment@ leeschools.net. Parents may also mail the documents, submit by fax to 335-1417, or place in the secure drop box outside the Student Enrollment Office entrance.

Parents who wish can visit the Student Enrollment Office located inside the Lee County Public Education Center at 2855 Colonial Boulevard in Fort Myers. The office is open from 9 a.m. to noon and 1 to 4 p.m. Monday through Friday. The office is closed from noon to 1 p.m. The Student Enrollment Office practices social distancing, so only one family member is allowed in the lobby.

arn to Learn Florida (ETLF), a 501(c)3 nonprofit whose mission is to empower incomechallenged students to complete college, has been awarded \$648,000 from AmeriCorps in partnership with Volunteer Florida. The grant

will fund 72 AmeriCorps members to be deployed as Near Peer coaches for postsecondary success to serve 900 hours each during the program year August 1 through July 31, 2022.

The funding is a part of a statewide initiative awarding \$17,189,370 from AmeriCorps to fund 37 programs in 2021-22. Cumulatively, these programs will recruit and manage 1,612 AmeriCorps members who will serve in 35 of Florida's counties, contributing 1,981,575 total hours of service valued at \$52,155,054.

"AmeriCorps members are on the front lines of service to Florida's communities and various areas of need," said Volunteer Florida CEO Corey Simon. "With this year's significant investment, we are excited to support the tremendous impact that these national service members will affect in schools, hospices and state parks throughout the Sunshine State."

"In 2020, an AmeriCorps grant launched our Near Peer Coaching for Secondary Success," said Brenda Tate, CEO of Earn to Learn Florida. "This year's AmeriCorps funding will help additional students pursue their dream of completing a postsecondary education with little or no debt. We are grateful to Volunteer Florida for securing this funding for Florida's students."

Near Peer success coaches support students as they transition from high school to a postsecondary education institution. Members focus on advising students, especially those from low-income backgrounds, through the complex steps toward college enrollment, including the admission and financial aid processes. The program targets economically disadvantaged students in Hillsborough, Pinellas, Sarasota, Lee and Collier counties, with plans to expand to other counties. Each Near Peer coach will receive a stipend of \$9,900, plus a \$3,000 scholarship for their continued education upon completion of 12 months of service.

Program Expanded To Control Pythons

he Conservancy of Southwest Florida, in partnership with the Fish & Wildlife Foundation of Florida, reports the success of expanding its sentinel snake program targeting invasive Burmese pythons that are devastating native species across the Greater Everglades. Through the collaboration, an additional 10 adult male "scout snakes" were captured and implanted with radio-transmitters to lead biologists to reproductively active female pythons across multiple breeding seasons.

Through the Fish & Wildlife Foundation of Florida "Conserve Wildlife" license tag grants, the Conservancy of Southwest Florida's groundbreaking research and removal program was expanded by 40 square miles into Picayune Strand State Forest, a critical wildlife management area with an active Everglades restoration project. Male scout snakes are effective at locating reproductive females within areas where they would otherwise remain undetectable.

"We were thrilled to fund such an innovative approach to combating

invasives," said Andrew Walker, foundation president and CEO. "The Conservancy is using science and speed to remove one of the biggest threats to wild Florida. We look forward to partnering with them again to advance this work.

Three biologists removed 192 adult pythons weighing approximately 7,800 pounds, including 105 female pythons containing over 4,000 developing eggs, over two breeding seasons.

The massive size of the female pythons located in the project expansion area indicates that there was limited removal effort placed on these invasive snakes in an ecologically critical area," said Ian Bartoszek, environmental science project manager for the Conservancy. 'It is mission critical to continue to apply pressure on the existing python population as these animals have had over a 20-year head start expanding their population throughout the bio-region.'

Smooth Rattlebox

mooth rattlebox (Crotalaria pallida var. *obovata*) is an all-too-common shrub in wild areas, disturbed sites and even preserved lands.

This pretty weed's native range is tropical Africa to Taiwan. It was one of several plants in the genus Crotalaria originally introduced to the U.S. because, like many members of the pea, or bean, family, they stabilize soil and are nitrogen-fixers.

However, it turned out that the seeds are toxic to livestock.

It has since become naturalized in Florida, meaning that it easily selfcultivates. Furthermore, it has highly invasive potential and is considered a noxious weed.

In fact, the species is being formally assessed and considered for invasive

The erect multi-branched stems have short flattened hairs and can grow to a height of nine feet.

The leaflets on the alternate trifoliate leaves are elliptic or obovate. The center leaf is larger than the lateral ones and is often pointed. The leaflets of one to three inches long have flattened hairs on the undersides.

The elongated terminal flower spikes bloom throughout the year.

They have pendulous closely arranged yellow flowers of about a half-inch long. The petals often have reddish brown streaks.

Like many members of the pea family, this species' flowers take an elaborate form, in this case oblong wings, a rounded banner and a projecting curved

The fruit is a cylindrical inflated pod of about an inch and a half long containing 30 to 40 seeds.

The name rattlebox refers to the noise the seeds made. They detach from the pod at maturity and "rattle" when the

pods are shaken.

Despite its undesirable qualities, one thing can be said in this wildflower's favor: It's a food source for birds and a nectar source for butterflies.

Beach Blitz

Fishing action out along our beaches has really picked up over the past few weeks. This fall fishery presents anglers with some amazing sightfishing opportunities

on a wide variety of species. Conditions are everything when fishing along the beaches. The longer our weather stays consistently calm, the more predictable this bite is. During calm weather periods, it's possible to return to the same places day after day.

My main target out on our beaches this next few months is tarpon. These amazing game fish stack up on schools of bait often within casting distance of the beach. Fall post-spawn tarpon are hungry as they are packing on pounds before they migrate south. Watching them crash the surface as they gorge on these schools of bait is an amazing sight. Unlike our spring tarpon fishing, these fish are much more willing to eat a bait with a hook in it.

With so many other types of fish feeding in these same baitfish schools, it's often best to wait until you get a clear opportunity to make a cast to them. Sharks, ladyfish, jacks, mackerel and even sailcats are all feeding on these bait schools too and will get to your bait

before the tarpon. Live pinfish under a float are my bait of choice.

Feeding Spanish mackerel and ladyfish

mark the places to start your tarpon hunt. Usually these frenzies happen in clouds of fry bait in relatively shallow water

normally within a mile or so of the beach. Anywhere from Fort Myers Beach north to Redfish Pass is a good place to get started. Seems the further south you run, the less boat pressure there is.

Many days you will have these tarpon all to yourself without another boat in sight. Run the beaches while looking for any kind of bait, birds and life. Once you locate this life, shut down and watch. Some days, the signs are very subtle with just tips of tarpon fins showing, while other times they can be seen breaking the surface as they gulp mouthfuls of fry bait.

Something else we find this time of year out on the beach are large muds. These muds seem to disorient the bait fish and are often where the tarpon are feeding. I'm convinced tarpon are mudding the bottom by digging or stirring it up to set up a place to feed.

This action out on the beach can continue as late as January or until we experience our first major cold front dropping water temperatures below 70 degrees. The past few years, this bite has finished up by around Thanksgiving. For the next few months, I will take advantage of any chance I get to fish this beach bite with or without clients. Although it's not as consistent as our spring tarpon fishery, it will bring some of the most wide open tarpon fishing of the year.

CROW Case Of The Week:

Softshell Turtle Hatchlings

The Florida softshell turtle (Apalone ferox) is the largest species of softshell turtle in the country. This turtle has an elongated head, a long snorkel-like nose and large webbed feet, each

sporting three claws.

Unlike hard shell turtles, the Florida softshell turtle has a cartilaginous carapace, which means its upper shell is covered in leathery skin that some say resembles a pancake. This skin color is olive green to dark brown – a pattern that serves as a form of camouflage to conceal turtles from potential predators.

Florida softshell hatchlings have a lighter carapace color with yellow and orange markings. These colors fade and are lost as the juvenile ages into an adult.

At CROW, the clinic has seen an influx of pregnant Florida softshell turtles, including some that were involved in accidents.

"We've had softshell turtles come in gravid for the past several months and have had hatchlings on and off since mid-spring," said CROW Rehabilitation

"After hatching, they are placed on damp paper towels until their yolk sac absorbs and then they are transitioned into a shallow water tub with foliage and rocks for basking," Frankel explained. "We keep them in our reptile room which is kept at ideal conditions for recovering

According to the CROW official, baby turtles do not require much assistance once they hatch.

reptiles, with high heat and humidity.

"Turtle and tortoise hatchlings are self-sufficient as soon as they hatch and do not require any assistance from the parents," said Frankel. "There is no real care aside from observation that is necessary. We just make sure they appear healthy after hatching and ensure they fully absorb their yolk sacs, then the rest is up to them."

Not only do turtle hatchlings take up a minimal amount of space in the reptile room, their stay at CROW is relatively short as well.

"They are typically released within a few days of hatching," said Frankel. "This group was released September 24 in Fort Myers, in suitable habitat."

In addition to this clutch of 19 eggs, CROW officials are watching the progress on another clutch of 11 Florida softshell turtle eggs from a different mother that are expected to hatch soon. Once those eggs hatch, the same care process will be extended to those baby turtles until they too are released to begin their lives in the wild.

"We try to put our animals back in the general area from which they came," said Frankel. "The second set of hatchlings, which hasn't hatched yet, will be distributed appropriately but not in the same locations as the first."

Private Land Needed For **Gopher Tortoises**

he Florida Fish and Wildlife Conservation Commission (FWC) is seeking landowners to help with gopher tortoise conservation efforts as part of the agency's Gopher Tortoise Recipient Site Program. The program benefits landowners and tortoises, and is compatible with other land uses, such as hunting and wetland mitigation.

The program provides landowners with an opportunity to generate additional revenue from their lands, as the landowner may charge a marketbased fee for each tortoise received at the site

The price landowners can charge per tortoise received at an approved site is not set by the FWC, so the landowner can adjust the fee based on their needs. Based on the current market for gopher tortoise recipient sites, landowners can generate more revenue from this program than ever before while contributing to the conservation of the species.

The program offers a variety of conservation benefits to gopher tortoises. Tortoises benefit by being moved out of harm's way when relocated from development sites to the safety of FWCpermitted recipient sites. Recipient sites minimize the loss of tortoises, preserve habitat, restock depleted populations and promote genetic diversity of the species.

Managing properties and habitat for the gopher tortoise has a conservation benefit for more than 350 other species that have been documented using gopher tortoise burrows. Many of these species are also state or federally listed.

"Landowners play a significant role in conserving gopher tortoise habitat throughout Florida," said Alex Kalfin, program planning and monitoring administrator for the FWC's Wildlife Diversity Conservation Section. "We are hoping we can get more property owners enrolled in this program, which is not only a critical component of gopher tortoise conservation in Florida

but also provides substantial benefits for

landowners."
FWC staff will assist property owners, whose lands meet the recipient site criteria, throughout the application process. They will also help landowners make improvements to their land to improve quality habitat for gopher tortoises and other wildlife.

The gopher tortoise is a protected species that resides in all 67 Florida counties. The tortoise is known as a keystone species, and its burrows serve as important refuges for 350 native species including threatened species such as the eastern indigo snake, burrowing owl and gopher frog.

Dangerous Use Of Public Roads **Action Upheld**

The Lee County ordinance prohibiting dangerous uses of public roads and rights-of-way within unincorporated Lee County, which had been challenged in court, was found constitutional on September 23.

The Lee Board of County Commissioners in April approved the ordinance. The Lee County Sheriff's Office immediately began to educate and raise awareness of the ordinance. Enforcement is used as a final step. Violations of the ordinance are punishable by a fine not to exceed \$500 and/or by imprisonment in the county jail not to exceed 60 days, as provided in Section 125.69, Florida Statutes.

Dangerous uses include stopping and standing on a median or engaging in any physical interaction between a pedestrian and an occupant of a motor vehicle within certain areas of unincorporated Lee County.

The board adopted the ordinance because increased use of public roads and rights-of-way by pedestrians to solicit drivers had led to heightened concern regarding pedestrian and driver safety within unincorporated Lee County.

The Cape Coral-Fort Myers metropolitan area currently ranks 11th in the nation for most dangerous places for pedestrians, according to the 2021 Dangerous by Design Report issued by Smart Growth America in conjunction with the Centers for Disease Control and Prevention.

The unexpected presence of individuals standing in the medians or interacting with drivers further increases the danger of collisions between pedestrians and motor vehicles, the board said.☆

Tuesday, November 2 – Public hearing to review map options;

Tuesday, November 16 - Public hearing to adopt new map; and

Tuesday, December 7 – Item on the Lee Board of County Commissioners agenda to certify for transmission to the Florida Secretary of State.

The new landing page can be found at www.leegov.com/countymanager/ redistricting. Residents also are encouraged to sign up for Lee County's newsletter by visiting www.leegov. com and clicking on the envelope icon. Recipients receive meeting notices with agenda links and other information. Following Lee County Government on Facebook also provides updates.

The goal of redistricting is to readjust the population between commission districts so that no commission district includes substantially more individual residents than the others. If commission district boundary adjustments are needed, Lee County can make such changes during an odd-numbered year. Given the late release of U.S. Census data this year, the normal 10-month process will be condensed to about four months.



Billy Summers

Stephen King has long been an author with a huge imagination. Known as a master of horror novels, his thrilling new novel is a definite switch. Billy Summers is about a good guy in a bad job. He's

a killer for hire and good at his job, but he'll only do his job if the target is a truly bad guy. Now 44 years old, Billy, a decorated Iraq war vet, wants out but he has to do one last hit.

Billy is offered \$2 million for his one last big job. He agrees to the assignment and settles down in a small Midwestern town, pretending to be a freelance writer working on a novel. He makes friends and becomes part of the community. As he writes his novel, actually a memoir based upon his time in Iraq, he learns things about himself that he had forgotten about decades ago.

Billy is intelligent, but likes to put what he calls his "dumb self" in front of those who hire him. He assumes new identities. While waiting for his target to arrive, he reads comic books in public but in private reads works by Zola and Dickens. With a great deal of careful planning, Billy carries out the hit, but questions whether or not he will be paid



what he was promised.

A new character joins the plot in the second half of the book. It is someone almost as dynamic as Billy, and together they form an unlikely team. To say more would rob the reader of the unexpected twist. It's one of the most compelling and surprising duos in King fiction. Many have called *Billy Summers* King's best book in years. It's a spectacular novel that is part war story and part love letter to small town America and those who live there. Billy is a complex

School Smart

Speech-to-text writing is an important tool for children to use, and there are many reasons why it's so helpful for the writing process.

It's a wonderful tool for getting ideas down quickly before children might forget what they want to say. A blank page can be intimidating for any writer and with speech-to-text, kids will participate in both vocalizing their words and ideas and simultaneously seeing their words appear "on paper." They don't have to worry about penmanship, grammar, or spelling at this initial stage of their writing, they just need to focus on the words they are choosing to use. This immediacy of seeing their words may reduce some feelings of intimidation and decrease some of the stress in the writing process. Children can watch their words fill the page and feel proud that they have come up with something to say. Once children have their first draft in front of them, they can move on with the writing process.

Speech-to-text typically has a spelling and grammar function. Children should use this tool as well. Spell check is a simple way for students to see that they have misspelled words, with the automatic underline quickly notifying students of a mistake. They can then go through their work and revise their grammar and ideas, correcting anywhere the technology misheard them and getting practice editing their own writing.

Another benefit of speech-to-text is the reverse process of text-to-speech that is also available with this tool. The computer reads aloud the student's work, and that way through hearing the text read aloud, the student can be sure that words or lines weren't skipped, improving comprehension.

Speech-to-text software is typically included on word processing programs like Word. Google Docs Voice Typing, Microsoft Dictate have a speech-to-text function and Chrome has a speech-to-text extension that is available. There are some apps as well that perform speech-to-text.

Writing is linked to critical thinking and has implications for academic success across all areas of the school curriculum. Children show what they know and have learned through writing. And, of course, they must be good writers to do well on tests, complete homework assignments and eventually compose advanced essays and reports. Speech-to-text is a great tool to help them become great writers.



First Volley: House Ways And Means Committee Unveils Tax Proposal

In my efforts to keep you up to date, here's a synopsis of President Biden's tax proposal that arises from the House ▲Ways and Means Committee. The bill is not law until passed by the Senate and House and signed by the president. There will likely be changes through negotiations. Here's my summary:

Gift and Estate Tax Provisions

Estate and Gift Exemption Decrease - Currently, the gift and estate tax exemption is \$11.7 million per taxpayer. The bill would reduce it to approximately \$6,020,000, effective

December 31, 2021.

If You Own a Farm - You have a special exemption to reduce its value, rather than being taxed at highest and best use. The farm provisions are the only protaxpayer provisions in this legislation.

Taking Away Estate Planning Tools - Many of you know that the Sheppard Law Firm uses advanced estate planning strategies, including SLAT (Spousal Lifetime Access Trusts), IDGT (Intentionally Defective Grantor Trusts), and sale to IDGT, GRAT (Grantor Retained Annuity Trust) and QPRT (Qualified Personal Residence Trust), to name a few. All of these strategies involve retaining grantor trust status for income tax purposes yet enabling a transfer for gift tax purposes, excluding assets from the grantor's estate. While it's unclear whether the GRAT and QPRT would be eliminated under the law as they are both sanctioned by the Internal Revenue Code, IDGT and SLAT strategies would be eliminated. There are other issues with QSST (Qualified Subchapter S Trusts). The date of enactment of the law would be the date where these strategies are eliminated.

Insurance Trust Rules Change – Irrevocable Life Insurance Trusts (ILIT) would no longer be able to use trust income to pay premiums without including the insurance proceeds in the grantor's estate for estate tax purposes.

Sales to IDGTs - Another tool in our arsenal to minimize gift and estate taxes is to create a sale between the grantor and an IDGT. Under the current law, no capital gain is recognized. This legislation would force recognition of capital gain.

Valuation Rules - You may know that when transferring interests in businesses, real estate and even investments, the current law provides for a discount when those interests are held in a company, partnership or LLC. The discounts relate to the fact that the closely held business interests aren't marketable, are usually a minority interest and lack voting control. Passive business interests and other non-business assets would no longer receive these discounts on valuation. The only exception are active business interests where the taxpayer is an active participant.

Income Tax Provisions

Estates and trusts with income over \$100,000 pay an additional three percent surtax on their modified adjusted gross income.

Keep in mind that irrevocable trusts that don't pass through their income currently are taxed at the highest federal marginal rate to the extent that the income is equal to or exceeds \$13,050. Individuals don't pay the highest marginal rate until they have \$523,000 of taxable income. This three percent surcharge on AGI over \$100,000 adds to the disadvantage of accumulating income.

Qualified Small Business Stock Exclusion - New provision cap gains that would otherwise not be taxable at 50 percent.

What Is Not Part Of The Bill?

Step-up in Basis - Congress did not include a provision that would eliminate the step-up in tax cost basis at death.

No Deemed Sale at Death – which would have triggered capital gains. No Added Limitations on GRATs – so short-term GRATs appear to remain

No Elimination of Dynasty Planning – to the extent that taxpayers have enough exemption left to engage in planning that eliminates estate taxes at each generational level.

No Increase in Gift/State Tax Rates - while many strategies are threatened, the actual tax rate will remain the same.

No Estate Tax Surcharges for Billionaires - Good news for Jeff Bezos and Bill

What Should Clients Do Now, Before A Bill Passes?

Clients should focus on creating SLATs, undertake sales to grantor trusts using valuation discounts, use their exemptions before they lose them. For clients who have already exhausted their gift tax exemption but not their GST tax exemption, it may make sense to gift equal to the balance of their GST tax exemption and pay tax on the gift. If the donor lives for three years from the date of the gift, the gift tax paid will be removed from the estate.

I'll keep you posted with further developments as they transpire.

Plans for the project include consolidating the transportation security administration checkpoints into a new 16lane configuration and providing additional seating, concession spaces and a business lounge. In total, more than 164,000 square feet of space will be remodeled and 117,000 square feet of new walkways and concession space will be added to the airport terminal.

The consultant working on design and planning is Atkins North America, Inc. The construction manager/general contractor for the project is Manhattan Construction (Florida).

The project is being funded with

grants from the Florida Department of Transportation, Passenger Facility Charges (PFCs), airport revenue bonds and Lee County Port Authority construction funds. No ad valorem (property) taxes are used for airport operation or construction.

The Lee County Port Authority operates Southwest Florida International

Frankly Speaking

7 nute Rockne is regarded as one of the greatest coaches in college football history. The College Football Hall of Fame identifies him as "without question, American football's most-renowned coach." From

Wikipedia: "Rockne helped to popularize the forward pass and made the Notre Dame Fighting Irish a major factor in college football. On November 1, 1913 the Notre Dame squad stunned the highly regarded Army team 35-13 in a game played at West Point. Led by quarterback Charlie "Gus" Dorais and Rockne, the Notre Dame team attacked the Cadets with an offense that featured both the expected powerful running game but also long and accurate downfield forward passes from Dorais to Rockne. This game was not the "invention" of the forward pass, but it was the first major contest in which a team used the forward pass regularly throughout

During 13 years as head coach from 1918 to 1930, Rockne led Notre Dame to 105 victories, 12 losses, five ties and three consensus national championships, which included five undefeated and untied seasons. Rockne posted the highest alltime winning percentage (.881) for a major college football coach. He was also shrewd enough to recognize that intercollegiate sports had a show-business aspect, so he worked hard promoting Notre Dame football to make it financially successful.

So what? Brian Kelly just surpassed Rockne's record with his 106th victory in a dominating win over Wisconsin last Saturday. Kelly has been coach since the 2010 season. However Kelly also knows his legacy, and said "I'm now the winningest coach at Notre Dame without a national championship." We know his

The Chicago White Sox have now made the playoffs two seasons in a row, getting in as a wild card team last year and winning the division this year. So what? This is the first time the Sox have been in the playoffs in back-to-back seasons in

their history, 121 years. Surprising.

Clemson is now a .500 team. So what? Four collegiate teams, Alabama, Clemson, Ohio State and Oklahoma, have accounted for 71 percent of the playoff spots since the new playoff system began seven years ago. Ohio State and Clemson have losses this season, and Alabama and Oklahoma have squeezed out some close victories. Sports Illustrated asks the question "Are we getting closer to parity?" Time will tell.

The Chicago Bears averaged 1.1 yards per offensive play in last Sunday's 26-6 loss to the Cleveland Browns. So what? This was the second fewest by any team in a game this century, according to the NFL on CBS. Chicago managed just 47 yards on 42 offensive plays. They had just one net passing yard after taking into account the 67 vards lost on nine sacks, three more sacks than completions for QB Justin Fields who was 6 for 20. For Cleveland's

defense, it was the fewest yards they have allowed since 1946. Da Bears.

The United States clinched the 2021 Ryder Cup on Sunday after rookie Collin Morikawa secured the final half point to get to a 19-9 victory. So what? As reported in The Sporting News, it's the largest margin of victory in Ryder Cup history since the 28-point format came about. It's the first time since 1979 and 1983 that Team USA won back-to-back home Ryder Cups after winning in 2016

My daughter Hillary ran her first full Ironman last Sunday in Chattanooga. So what? She said because it was so hot in her last half-Ironman in Ohio, this was actually easier for her to do because of both the temperature and the number and helpfulness of the volunteers. The ratio was 1:1 between volunteers and athletes, allowing the athletes a great amount of support over the 145 mile course - a 2.4-mile swim followed by a 116-mile bike ride and concluding with a 26.2-mile marathon. One example was getting help with a quick tire repair on the course, or getting a pair of goggles to use when hers broke right before the swim. Hillary was very pleased to have completed this in just

over 14 hours. Amazing.

Our good news story is another Paralympics story from the Good News Network. "In the spring of 2016, 17-yearold Beatrice de Lavalette was waiting for a flight when she got hit by the terrorist bombing at Brussels airport. Along with serious burns and a spinal cord injury, De Lavalette lost both legs below the knee.

De Lavalette began riding horses at age three and by age 12, she'd taken up dressage. Getting back in the saddle was no easy feat in light of her injuries, but she was determined to do so as soon as she was able. Five months after the bombings, thanks to her grit, determination, and extensive regimens of rehab and retraining, that's exactly where she was. "I had no muscle, I was just skin and bones, so being back on the saddle with no sense of balance was really uncomfortable. But with time, I was able to build up the muscle and work on my balance, and it got easier with time," she told CNN.

Unsurprisingly, Beatrice was depressed as she tried to come to terms with her injuries. She admits to crying a lot in the hospital until an unexpected visitor turned things around for her. "DeeDee (my horse) saved my life," Beatrice said in an interview on The Doctors. "My mom had figured out a way to get DeeDee into the hospital parking lot. I said, 'Where's my [wheel]chair?' I went outside in the rain and as I got closer, she came towards me and put her head against my chest. That moment made me decide that I wasn't going to give up on life.

It's taken a great deal of hard work for her. Having to adjust to her body's new normal was, in many ways, like having to learn to ride all over again. But as her efforts began to pay off, the Paralympics seemed the perfect outlet to showcase her hard-earned skills. After making her first appearance as part of the U.S. Para-Dressage team in 2020, De Lavalette set her sights on Tokyo, where she rode an "awesome" 14-year-old Dutch Warmblood named Clarc. "The reason I've gotten to this level of recovery is because of my horses," De Lavalette told News 4 JAX. 'I can't change what happened, but I can succeed at being me. As I have said many times, I was in the wrong place at the wrong time. What else is there to say? I have a new life in front of me," she said on her website. "What's important is that I'm alive and I feel that I will do something grand with my life." Beatrice, 22, partnered Clarc to fifth place in the grade II individual (70.27 percent) and sixth in the freestyle (72.19 percent)." To me, Beatrice finishes first in attitude and determination.

Coconut, Nut **Butter Paleo Banana Cookies**

he doctor definitely has a sweet tooth. Yet, he wants to avoid consuming white sugar/flour products because of the ill effects on one's health. Thus, the dietitian is always trying to come up with something "healthier" but satisfying to the sweet tooth. When looking at some very ripe bananas, she decided to combine a recipe for keto cookies with one of the flourless banana cookie recipes. The results were excellent according to the doctor. Unfortunately for those with whom we are sharing this recipe, quantities are estimated because of our tendency toward nonmeasuring when cooking.

We want to encourage you to try these types of recipes instead of consuming products laden with sugar, flour and preservatives/chemicals. In a recent staff meeting at Caring Medical, we were discussing the cumulative effect of maximizing health by doing a lot of little things in our lives to lessen the toxic load our bodies have to fight in order to keep diseases at bay.

We all know that excessive consumption of sugar leads to

adult-onset diabetes, cardiovascular disease as well as stresses the immune system. Chemicals and processed so-called food lead to toxin build-up and increases strain on our livers and other organ systems to detoxify. Control what we can control – and food is a major part of that, right? Try to eat as clean as you possibly can. It's worth it and work towards developing a lifestyle, not a "diet."

Back to the recipe. What you need: 2 ripe bananas, 1 cup nut butter (we used half peanut butter and half coconut almond butter), 1 egg, 1 tsp. baking powder, 1 tbsp. raw honey, 1 tsp. kosher sea salt, 1/2 tsp. cinnamon, 1/2 cup chopped pecans, 1/2 to 2/3 cup unsweetened coconut flakes, 1/2 cup dark chocolate chips, and a heaping 1/2 cup gluten-free chocolate rice cereal or oats.

What to do: Preheat oven to 375. Mash bananas in large bowl, add nut butter and stir vigorously until combined. Add egg and continue mixing, followed by baking powder, honey, salt and cinnamon. Stir until well mixed. Add nuts, coconut and chocolate, folding in well, followed by cereal. Add more of these ingredients if dough seems too wet. Chill cookie mixture for about 30 minutes. This is a key step because it helps solidify the dough. Drop heaping teaspoons of dough on cookie sheet lined with parchment paper. Bake eight minutes. Remove from oven and consume with a lovely cup of espresso. Cheers.

Chantix Recalled By FDA Due To Contamination

ear Readers: If you use the medication called Chantix, you need to stop, according to the United States Food & Drug Administration (FDA). This

medication has just been officially recalled by Pfizer, in all lot numbers, sizes and dosages. It goes by the chemical name varenicline.

The medication was FDA-approved for the masses in May 2006 because studies proved it worked better at placebo to get people off tobacco. The studies showed that in three months over 40 percent of people using Chantix were able to quit smoking. But that doesn't matter anymore because the medication was found to be tainted with a cancercausing chemical called nitrosamine. For clarity, I want to be sure you know that Bupropion, a different drug altogether, is not impacted by this recall. It is also used for smoking cessation and may serve as an alternative for some of you. It used to go by the name of Zyban, but the brand was discontinued - only generics are available today.

Since 2006 when the FDA approved it, millions of men and women took Chantix (varenicline) tablets to help them with their nicotine addiction. The reasons vary for why a person would want to quit smoking but, for sure, smoking leads to disease and disability, as well as faster signs of skin aging due to the free radical damage done to the skin.

Everyone knows that it can increase one's risk for emphysema, chronic obstructive pulmonary disease (COPD) and lung cancer. So to have a medication that helps such as Chantix was something that everyone welcomed. It is ironic that those who feared lung cancer induced by smoking – who took Chantix to stop – now have to face the fact that they were likely exposed to the cancer-causing nitrosamine found in the drug itself!

According to the FDA official statement from their website:

Long-term ingestion of N-nitrosovarenicline may be associated with a theoretical potential increased cancer risk in humans, but there is no immediate risk to patients taking this medication. The health benefits of stopping smoking outweigh the theoretical potential cancer risk from the nitrosamine impurity in varenicline.

Nitrosamines are common in water and foods, including cured and grilled meats, dairy products and vegetables. Everyone is exposed to some level of nitrosamines. These impurities may increase the risk of cancer if people are exposed to them above acceptable levels over long periods of time.

If you took Chantix, I would not think you are in any immediate danger, so try not to worry yourself, but do take action to improve your lifestyle and increase antioxidants in your body. It would be great if you could have basic blood work drawn to make sure you're healthy and strong. If you smoke (or if you took Chantix), I highly recommend Vitamin C and Catalase as two antioxidants to fight oxidative damage in the body. These are very strong antioxidants that work all over to do good housekeeping on your cells.

Designing A Bedroom For Multiple Children

Hang up artwork drawn by both children, so they each understand that even though they are sharing a room, they also have their own individual stakes in the living area. Each child could have a little space of his or her own within the larger room, that could be as small as separate drawers or as large as individual night tables, depending on how much space is available. Sharing a bedroom doesn't have to be a challenge and can even bring siblings (or visiting cousins) together.





uto accidents are extremely scary for all those involved. Call for help – Call 911 immediately who will then alert the responsible utility.

Wait for the OK – Wait for a utility or emergency worker to give you the okay before exiting your vehicle. The only reason to exit your car is if it on fire. If your car is on fire, jump clear of the

vehicle with your feet together and hop away with your feet remaining together.
